I thought I would just drift off again when the voice of my wife who was also awoken asked "Aren't you going to report it?" I have a confession; there are times if the noise fades into the distance I DO just go back to sleep. So my wife's comment was food for thought. I came to the conclusion that my lack of action could be contributing to the problem. I think to avoid getting out of bed I had convinced myself that nothing could be done, and besides I don't want to explain to someone that there really is not a problem now. I think it is more important to remember is that if 1st District resources are available and they intervene I have saved one of my neighbors from the disruption. Each time I and others ignore and do not report it we fail to give the 1st District the information needed to act as well as the opportunity to identify and proactively deal with a reoccurring problem. I thought to myself, if someone on the previous block had reported it, I may have slept undisturbed. The 1st District continues to emphasize that we use Report It/Record It 935-7211 for all nuisance activity. (NOTE! Report It/Record it is for nuisance complaints only. Help Stop Illegal Dumping

any people think that because yard waste is biodegradable, it is "natural" to dump these materials on city streets and boulevards. Such dumping not only harms neighborhood aesthetics and creates nuisance conditions, it is also illegal.

Illegal tree and brush disposal is becoming a growing problem in the Murray Hill neighborhood. Many residents have experienced problems with people in our community illegally disposing of brush and bulky material. Dumping of household garbage is usually not a problem, since this is collected once per week. However, since the collection frequency of brush and bulky items is less frequent, many residents have made a practice of illegally dumping these materials on city streets. The islands and right of ways on East Newberry Boulevard are especially plagued with the illegal dumping of yard waste.

In 2010-2011, the city spent \$175,000 clearing illegally dumped debris and the problem is getting worse. So much so, that in 2010 the Common Council increased the fine for illegal dumping from \$120 to \$1,500 to \$5,000 per offense. The Common Council also "approved a tip hotline whereby callers can be eligible to receive reward money after anonymously providing information on incidents of illegal dumping of debris and/or hazardous materials. Illegal dumping includes dumping of items, brush, and/or materials on streets, sidewalks, parking lots, vacant lots, alleys, or at vacant properties."

If you see or know of illegal dumping call the We Tip hotline number at 1-800-78-CRIME. You can be rewarded up to a thousand dollars if your information leads to prosecution. If you see illegal dumping in progress call the Milwaukee Police Department's non-emergency number.

Department of Neighborhood Services (DNS)

he Department of Neighborhood Services (DNS) and the Milwaukee Police Department (MPD) are **L** continuing their collaboration in the UWM area. DNS is notified by MPD every time they issue a noise citation in the UWM area. DNS is conducting an exterior and zoning inspection on the property shortly thereafter. Exterior violations such as painting will be cited, as well as zoning issues such as parking on unpaved surfaces, an illegal 3rd floor unit, and overcrowding. DNS attempts to contact the owners and discuss the issues that initiated the inspection. MPD also provides DNS with pictures of interior zoning violations, which we can use to issue orders. Since March 2012, DNS has inspected 62 properties. Over 70% of those properties were cited by DNS for code violations. The goal of this initiative is to educate tenants and landlords on what types of behavior are legal in the City of Milwaukee in order to reduce noise and all the associated problems that come with such nuisances.

There are several code questions I am frequently asked. The City of Milwaukee requires a permit for most signs, but there are some exceptions. In residential districts, one sign, not to exceed 6 square feet, is allowed to advertise the sale or leasing of a building. Temporary window signs that do not exceed 25% of the glazed portion of the window, and for not more than 30 days, are allowed. On private property, one political sign not to exceed 6 square feet is allowed to be erected.

Many times, especially in the UWM area, items are left at the curb when students move out. Bulk waste changes went into effect in 2011. DPW will only pick up one (1) cubic yard of extra material placed out for pickup on your designated collection day. This is about the size of an easy chair. Call 286-CITY (2489) to request pickup of larger piles for a fee.

Overcrowding complaints are common, but sometimes an owner obtains a rooming house license which allows more than 3 unrelated people to occupy a unit. A Rooming House is defined as any building or part of any building or dwelling unit occupied by more than 3 persons who are not family for longer than one night. Usually a bathroom is shared by the roomers. No more than three unrelated individuals may occupy a unit unless a rooming house license has been obtained.

The Residential Rental Inspection Program (RRI) was created to manage city property to ensure the health and safety of the public. The area covered is Edgewood Ave. to Newberry Blvd., and Cambridge Ave. to Hackett Ave. The goal of the program is to prevent the deterioration of units, and identify hazardous conditions to prevent fires and promote safe living conditions. Non owner-occupied rentals, except owner occupied duplexes, and all buildings with 3 units or more, are inspected as part of the RRI program. Owners receive either a 1 or 4 year certificate.

On several interior inspections I notice extension cords used improperly, and in many cases dangerously. Any device that is permanently mounted CANNOT have an extension cord on it. Typically washers, dryers, refrigerators, builtin dishwashers, microwaves, and wall ventilation fans are considered permanent. Trouble lights strung across a ceiling and nailed in place are illegal. Adding extension cords to a circuit increases resistance and heats up the wire. The chances of a fire are increased with longer cords. Never use an extension cord with air conditioners or space heaters.

SoLo Pizza on Oakland

he name and entrance have changed but not the wood-fired pizza. Many neighbors remember the ■ Oakland Trattoria before it was split a couple of years ago into SoLo Pizza (2856 N. Oakland Ave) and the Black Rose Irish pub. The name SoLo comes from its location south (So) of Locust (Lo), even though it is only by a few yards south of this main intersection; to complement the name change they have added a small size pizza called the SoLo. Remodeling includes the addition of a vibrant mosaic of "flames" over the main entrance that flows to a view of woodfired ovens for pizza; the interior design changes followed this theme with hand-crafted mosaic art on the walls. The south half of the former Trattoria was transformed into the Black Rose Irish Pub, one of three Irish pubs (Harp, Trinity) run by the owner, R.C. Schmidt. The two next-door restaurants share the same kitchen so diners in the area can choose from thin crust California style pizza to Irish Pub bar food.

SoLo is open for lunch and dinner seven days a week (Mon-Fri, 11am-11pm; Sat-Sun, 10am-11pm) and has recently added a brunch on weekends from 10 am-3 pm. The menu offers appetizers (e.g., Italian nachos, bruschetta), soup and salads (e.g., goat cheese, pine nut and sundried tomato salad), sandwiches (e.g., parmesan chicken), various pastas and of course, thin crust wood fired pizza. You can choose from a variety of pizzas (\$5.95 - \$16.95) or you can build your own pizza with various choices of meats (9 choices; e.g., pepperoni, prosciutto, anchovies); vegies (13), cheeses (6 choices; e.g., Gouda, goat, gorgonzola) and extras (10). To attract the university clientele, they have added a UWM Pizza of the



month special. The wine list includes about 25 wines and taps of several regional and national beers.

Their weekend brunch (\$4.95 - \$8.95) offers breakfast classics, (e.g., eggs, French toast, fruit plate), skillets (e.g., Mediterranean, Margherita), build your own pizza omelet and some specialty dishes (e.g. stuffed French toast, breakfast burrito). Dine-in, carry out and delivery options are available. The facility is handicap accessible and has been upgraded with Wi-Fi.

You might have recently seen that SoLo has built on its reputation as a Milwaukee food establishment by its recent venue at Summerfest. Check out SoLo as another great neighborhood option for lunch, dinner or weekend brunch. For more information visit www.solopizzamilwaukee.com or on twitter use SOLOPIZZAMKE.

WeTip: People's Voices Are Heard

People are often reluctant to get involved in safety and security issues in the neighborhood. The City has added the WeTip crime hotline as a resource for people who have information about a crime, but are afraid to tell anyone. WeTip is a supplemental program to our Report It/Record It program (See insert flyer) where you can ask for a citation to be issued for an offense. For example, you can call WeTip if you have information on illegal dumping of rubbish or snow by commercial businesses on the boulevards – dumping of all kinds of items has become a major problem in many neighborhoods. This program also is aimed at reducing graffiti vandalisms in the alleys, drug houses on your block or other serious crimes in the neighborhood.

If you want a safer neighborhood, call WeTip anonymously at 1-800-78-CRIME. You may be eligible for a reward up to \$1,000. In Milwaukee County alone, some 20,000 anonymous callers to WeTip have supplied information to law enforcement resulting in more than 900 arrests and approximately 600 criminal convictions. The hotline is answered by bilingual operators 24 hours a day, 365 days a year. Calls are taken for all crimes. All calls are anonymous, not just confidential. Do your part by calling WeTip to keep our neighborhood a safe place to live.

Murray Hill History – Did you know?

Mass Transit: 1950's to Present

he diesel buses that first appeared in the city around 1950 are what most citizens associate with mass transit in Milwaukee. Actually, the transit system has been evolving regularly due to economic fluctuations, the Great Depression, two World Wars, the development of technologies and the growth of the City. Transportation vehicles have changed in Milwaukee from the horse-drawn streetcar (1860-1894) to the electric streetcar (1890-1958), the gasoline buses (1920-1967), the electric trackless trolley (1936-1967) and our currently used diesel bus (1950-present). The rapid change to buses from electric streetcars and electric trackless trolley cars was driven by the separation of transit operation in 1952 from the electric utility and the sale to a private company, Milwaukee and Suburban Transportation Corporation.

The new transit company purchased 40 new, 40 ft. long, non-air-conditioned busses from General Motors in 1953. The east side, however, still had a mix of transportation vehicles during this transition that included diesel buses used for the Capitol Ave. route (#62) and the Wisconsin-Prospect-Downer route (#30); the electric trackless trolley buses were used for the majority of the Oakland Ave. (#15; now green line), Center St. (#22) and North Ave. (#21)

routes. These trackless trolley routes were replaced by diesel buses in 1962 and the first Freeway Flyer was added in 1964. The purchase by Milwaukee County in 1975 of the privately owned transit company sustained the existence of a City transit system and with additional investments from 1970's to early 1990's Milwaukee County Transit System (MCTS) became a nationally recognized, award winning transit system.

The growth of the University Wisconsin at Milwaukee (UWM) during the 1970-80's, as primarily a commuter campus, drove the need for more transit routes and connections in our area. Newly created U-Bus routes

were added and established routes were extended to connect students and employees directly with the UWM campus. The Capital Avenue (#62 - Red Line), North Avenue (#21), Burleigh (#60) and Center St. (#22) routes now all came to the UWM campus. Special U-Bus routes were added that included the Holt-College (#40U), State Fair-Whitnall (#44U) routes and more recently the Brown Deer (#49U) route. Today there are six local bus routes and three express bus routes servicing our neighborhood that connect us to jobs and school, shopping at the Bayshore Town Center, Mayfair Mall and the Shops of Grand Avenue or various entertainment venues.

MCTS has continued to provide innovative solutions such as clean diesel, low floor buses, bike racks, commuter value pass partnerships between employer and employee and, most recently, direct access to the airport on the new green line. However, the decrease in funding in the 2000's, recent significant state budget cuts, and the fact that the transit system is one of last in the country to not have dedicated funding has created more than great challenges. MCTS needs our help and support. The viability of the neighborhood and the city require that a viable transit system exists now and in the future.



Report It, Record It: 935-7211

As residents of Milwaukee's East Side, we have a strong desire to live in harmony with all of our neighbors. We have the right to enjoy a fine quality of life, free from nuisances and disturbances. The City of Milwaukee Code of Ordinances, Chapter 80-63, prohibits excessive noise, or that which is disturbing at 50 feet outside the property line. The Milwaukee East Side Neighborhood Associations have an excellent working relationship with the 1st District of the Milwaukee Police Department and have adopted a program to enhance police response and outcomes in our community. This program is called **Report It**, **Record It**.

WHO: All East Side Residents

WHAT: Report It, Record It

WHEN: Any time, day or night, that you are disturbed by excessive noise (including transient or moving noise),

trespassing, property violations or any other objectionable behavior. NOTE: for emergency situations,

always call 911.

WHERE: Anywhere on the East Side

WHY: (1) Because we all have the right to the quiet enjoyment of our homes.

(2) To allow more effective allocation of MPD resources. It creates a record of disturbances that occur in our neighborhoods and allows MPD to meet their commitment to follow up on citation requests the next day in the event that they are unable to respond at the time of the call.

(3) Your **Report It, Record It** call triggers communication between the MPD, the Milwaukee Department of Neighborhood Services (DNS) and UWM. These agencies are cooperating to tackle neighborhood problems. For example, noise complaints result in landlord warnings, possible fines by DNS, possible tenant evections and notification to UWM. Murray Hill receives police service call data from District 1 on a monthly basis and analyzes prevailing trends which it shares with the community. 
HOW: Report It: Call the Milwaukee Police Department 1st District Shift Commander at 935-7211.

Inform him or her that you are calling in a "Report It, Record It" complaint and provide as much information as possible on the location and identification of the offenders (number of people, license plates if applicable, etc.). If you are willing, inform the shift commander that you would like a citation issued and you would be willing to testify as a witness if necessary. Even if the 1st district is unable to respond due to call volume, they will follow up on the incident.

In an emergency, never hesitate to call 911.

Record It: Take detailed notes about the situation (date, time, addresses, etc.). Your notes may be needed in the event that you are asked to testify in court or to provide valuable information to the City and MPD when they seek to follow up with landlords.

Please remember that this program is new. Murray Hill is the east side liaison and works with District 1 to streamline and improve this system. Your feedback is encouraged. The Milwaukee Police Department will be devoting special attention to the campus area in an effort to reduce complaints of disorderly conduct and other violations. In order to reduce complaints, maintain order and protect the well being of individuals, I would like to inform you of the following fines that may be incurred as a result of your actions. I remind you, officers will aggressively enforce the ordinances and **CITATIONS WILL BE ISSUED!**

Property owners will be notified of violations occurring on their property. Future violations may result in the property owner being assessed administrative and enforcement fees, which may ultimately jeopardize your residency arrangements.
